

Fall Creek Valley Conservation Club Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to fcvcc.org and Fall Creek Valley Conservation Club and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Fall Creek Valley Conservation Club (FCVCC) include fcvcc.org.. By using the FCVCC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, FCVCC may collect personally identifiable information, such as your:

- First and Last Name

In certain situations, we may additionally collect things like:

Use of your Personal Information

Sharing Information with Third Parties

FCVCC does not sell, rent or lease its customer lists to third parties.

FCVCC may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on FCVCC or the site; (b) protect and defend the rights or property of FCVCC; and/or (c) act under exigent circumstances to protect the personal safety of users of FCVCC, or the public.
